By applying iron and manganese with elemental sulfur, it assures greater iron and manganese availability. Sulfur acidifies the area around the micronutrient release, thus providing a lower pH environment for increased nutrient up-take.

Directions for use

All applications of fertilizer should follow a soil test. Soil test for turf should be taken from the top 1" of soil and the garden from the top 6". On gardens, warm and cool season grasses, apply **Disper-sul 80% Plus Iron & Manganese** in the spring and early fall until the desired response is reached. These applications should be made to dry turf. Watering after application will aid in the dispersion of the granules. To minimize particle pick-up, do not collect clippings for the first mowing after treatment. Early fall applications are preferred. **In established turf (foliar) applications do not apply more than 5.0 lbs S/ 1000 sq. ft per application or turf discoloration can occur especially during hot dry conditions.** Higher rates may be used under irrigation, but use caution at high temperatures. If you are amending the soil for pH the table below should help you determine the proper quantity of 80% sulfur to apply on different soils
